TASK ORGANIZATION: MCB FIFTY-EIGHT (Herein known as the Battalion)

1. SITUATION. Normal rotation of personnel within the Naval Construction Battalions requires a continuous training program to maintain the desired degree of readiness. Accordingly, it is necessary to move approximately 80 men of the Battalion from CBC Davisville to the MARCORPBASE CAMLEJ in June 1966 for military training under the following conditions:

- a. Enemy forces. None
- b. Friendly forces.

- c. Detachment. 80 Man Provisional Rifle/Weapons Company.

2. MISSION. Pursuant to reference (a), the Battalion is to deploy a Provisional Rifle/Weapons Company of approximately 80 men to CAMLEJ in conjunction with general military training and the use of crew-served weapons.

3. EXECUTION. When directed in June 1966 by the Commanding Officer MCB FORTY, the Company will depart and deploy to CAMLEJ as an Attachment of MCB FORTY for a period of approximately four weeks. While in transit and during training, the Company will maintain the same readiness condition as MCB FIFTY-EIGHT.

4. ADMINISTRATION AND LOGISTICS:

- a. The total number of men deployed by MCB's FORTY and FIFTY-EIGHT shall not exceed 685.
- b. Standard operational procedures, set forth by reference (b), will be followed.
- c. Leave shall be administered in accordance with reference (c).
- d. The Company will utilize Annexes A, B, C, X and Z of reference (d) while it is under MCB FORTY OPCON.

5. COMMAND AND SIGNAL:

a. The Commanding Officer, MCB FIFTY-EIGHT, will direct the Officer in Charge, MCB FIFTY-EIGHT Provisional Rifle/Weapons Company to report to the Commanding Officer, MCB FORTY on 1 June 1966 for OPCON. Return of OPCON of the Company to MCB FIFTY-EIGHT shall be made upon the Company's return to CBC Davisville.

b. The Battalion is authorized direct liaison with MCB FORTY, MARCORPBASE CAMLEJ, and component activities.
